REMEMBER LAST WINTER?

It's hard to forget the eleven feet of snow we had in 2015. In many cases, the yards had more than four feet of snow covering furnace and water heater vents. Luckily, we had a few volunteers who shoveled out these vents to prevent furnaces from shutting down. Unfortunately, we will not have any shovelers available for vents this coming winter. So if your furnace vents and water heater vents are less than four feet off the ground, as most are, then you need to take corrective action before snow flies.

You may contact a plumber /HVAC contractor of your choice and hire him to extend your furnace exhaust and intake as well as your water heater exhaust. Please remember that these pipes must be a minimum of 3 feet and a maximum of 6 feet from the ground. Your plumber will be best able to determine the correct height for your location.

We are sorry for any inconvenience, but would also like to reiterate that you should have these vents extended if they are less than four feet and could get covered with snow. Because they are part of the internal plumbing system of your house the homeowner is responsible for the cost. Once again, we will not have any shovelers available this winter to shovel out exhaust



vents. Of course, you can hire someone to shovel out your vents at your cost.

The VSR Book Club met on October 1 to discuss *The Storied Life of A.J. Fikry*. All those present appreciated a thoughtful discussion.

The next meeting will be held on November 12. We will discuss *The Paris Architect* by Charles Belfoure. Here is a description of the book: "In 1942 Paris, gifted architect Lucien Bernard accepts a commission that will bring him a great deal of money – and maybe get him killed. But if he's clever enough, he'll avoid any trouble. All he has to do is design a secret hiding place for a wealthy Jewish man, a space so invisible that even the most determined German officer won't find it. He sorely needs the money, and outwitting the Nazis who have occupied his beloved city is a challenge he can't resist. But when one of his hiding spaces fails horribly, and the problem of where to hide a Jew becomes terribly personal, Lucien can no longer ignore what's at stake. *The Paris Architect* asks us to consider what we owe each other, and just how far we'll go to make things right. Written by an architect whose knowledge imbues every page, this story becomes more gripping with every soul hidden and every life saved."

On December 17 we will have a meeting that will focus on the writings of Laura Ingalls Wilder. Many of you remember her as an American writer noted as the author of the *Little House on the Prairie* books based on her childhood in a settler family from 1932-1943. During the 1970s and early 1980s, the television series *Little House on the Prairie* was loosely based on Wilder's *Little House* books. Villager Judy Culver, who has recently visited the Laura Ingalls Wilder Historic Home and Museum in Mansfield, Missouri, will lead the discussion and share with us some of her enthusiasm and insights. Come join us as we look back on this nostalgic period. Read or re-read any of her children's novels or her autobiography, *Pioneer Girl*.

We meet at 1:00 p.m. for refreshments and socializing, followed by the discussion at 1:30. All are welcome!

VSR Master Policy and HO6 Condo Insurance

The Village has replacement type insurance that will cover damage to a unit caused by fire, water, wind, etc. We have been pro-active in keeping the assigned value of our Village current with our insurance vendors to protect homeowners' investments. The Association's policy will extend to cover improvements made by owners to their units to the same extent that they would be covered

if they were an original part of the unit. However, it is incumbent on the Unit Owner to notify the Trustees in writing of all such improvements for incorporation into the Unit Owner's file that is held by the Association in the clubhouse office. A

copy of the invoice of the completed work is proof to the insurance company that the work has been done. New owners should verify that the Unit Owner's file accurately reflects the improvements to the unit.

Since our Master policy has a \$5000 deductible we ask condo unit owners to have at least \$5000 of dwelling insurance. \$10,000 dwelling insurance is often part of a basic HO6 policy, but you should ask if your policy has this type of coverage and what the amount is. You might also inquire about the cost difference between a \$500 and \$250 deductible for dwelling insurance in the HO6 policy. I found the difference was relatively small. In 2009 the Board of Trustees passed a policy related to stains caused by damage from roof leaks. The Board agreed to reimburse homeowners for completion of repairs up to the amount of their insurance deductible not to exceed \$250. Unit owners must have HO6 insurance that covers their furniture and personal belongings. Our policy will not cover such items. A good way to determine how much of that coverage you need is to go room by room and ask what it would cost to replace the contents of the room. The unit owner should also consider loss of use coverage that would pay for costs related to having to be out of the unit during a reconstruction time. A unit owner who has a significant loss should contact their HO6 insurance agent and let Evergreen Management, EMI, know the damage that has occurred. Usually the condo's insurance agent will want to see our Master Deed and policy. EMI can furnish these documents. If the building damage is greater than \$5000, the unit owner's HO6 insurance would pay for the \$5000 Master Policy deductible. The insurance company of the Unit Owner and our insurance company would work out the details.
